The **Clean Energy Transition Partnership** (CETPartnership) is a European initiative meant to foster energy transition through funding of demonstration projects related to enabling tools and technologies.

CETPartnership will launch its first annual Joint Call in September 2022.

Selected projects will benefit from:

- more than 100 million €, provided by national and regional funding agencies and institutions and by a top-up from the European Commission
- a structure that will accompany them through knowledge communities and impact groups fostering
  information and best practice exchange and guaranteeing an outreach of the results to European
  and international levels

CETPartnership is organized along seven Transition Initiatives (TRIs) covering all frontiers of energy transition, through a **solution-oriented approach**, focused on technology demonstration, adoption and market uptake.

TRI 1 is about Optimised Integrated European net-zero emissions Energy System.

These are TRI 1 Call Modules for 2022:

- 1. **Power Planning Tools**, concerning the <u>development of tools and methods to plan and operate the future integrated energy system</u>, fostering inclusiveness, sustainability and resilience
- 2. **RES Demo Power Flex**, focusing on the <u>demonstration of technologies and solutions to enhance flexibility</u> along the energy value chain, enabling the transition to high shares of RES in the European system

TRI 1 selected projects will have the opportunity to develop and demonstrate solutions and instruments to build and operate the future energy system:

- based on the electric grid, given that electricity is the main vector for renewable energy
- characterized by the integration of different energy vectors, grids and systems (gas, fuels, hydrogen)
   through storage and P2X
- in which renewable energy consumption is maximized, introducing flexibility services along the value chain
- pervaded by digital technologies
